<b>What is the overall <a href="#">deductible</a>?</b>	\$200/person or \$400/family for In- <a href="#">Network Providers</a> . \$400/person or \$800/family for Non- <a href="#">Network Providers</a> .	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> . Deductible resets January 1.
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. Primary Care <a href="#">Specialist</a> Visit <a href="#">Preventive Care</a> Vision for In- <a href="#">Network Providers</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. <b>Are there other <a href="#">deductibles</a> for specific services?</b>	No.	You don't have to meet <a href="#">deductibles</a> for specific services.
<b>What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a>?</b>	\$2,000/person or \$4,000/family for In- <a href="#">Network Providers</a> . \$4,000/person or \$8,000/family for Non- <a href="#">Network Providers</a> . Prescription drugs have a separate limit of <b>\$3,000</b> single/ <b>\$6,000</b> family In-network & out-of-network combined.
