### (\* EPC Recommended/Easiest Option)

Setup an online account/login credentials with any of the approved vendors:

- Easier to order ANY item you wish (Remember – our vendors offer various additional discounts on items not included on the spreadsheet.)
- Vendors can assist you with setting up your accounts and may be able to set up your district with an approval step if you wish. **You may use the spreadsheet to refer to, but it is not mandatory to use it at all.** You will find the deepest discounts on the items from the spreadsheet.
- The entire process is quicker. Less time entering your order and if items are in stock you can receive them as soon as the next business day.
- You can view additional information on every item (including pictures) as well as compare to other items they offer.
